## 2021-22 School Overview

Blake School is located in the small ranching town of Woody, located approximately 35 miles from Bakersfield. The school district services Transitional Kindergarten through the Eighth grade, in which the students are instructed in a TK-8 grade self-contained classroom. The school currently services 22 students with and ADA of 11.4. The school district employs one teacher/principal, a part-time teacher, a part-time instructional aide, one part-time secretary, and one part-time custodian. Blake school receives administration services and Speech/Language services, which are contracted through Kern County Superintendent of Schools. The school board consists of 3 board members. The instructional day begins at 8:00 am, and ends at 3:00 pm, Monday through Thursday. On Fridays, the day begins at 8:00 am, and ends at 1:00 pm. The school district has a resource room/computer room, which has a total of 6 student computers, 22 Chromebooks and one laptop with a Smartboard, all with T1 internet access. For students who are at high risk, tutoring is available, as well as small group workshops.

### Mission Statement

Blake School is committed to laying a firm educational foundation for each and every student. While serving in this diverse classroom, the staff, community, and Administration are determined to achieve success in producing and active learning environment for all students. The district has high expectations of not only the students, but of the highly qualified personnel it employs.
