2025-26 School Description and Mission Statement

Blake School is located in the small ranching town of Woody, located approximately 35 miles from Bakersfield. The school district services Transitional Kindergarten through the Eighth grade, in which the students are instructed in a TK-8 grade self-contained classroom. The school currently services 26 students with and ADA of 22.32. The school district employs one teacher/principal/superintendent, two part-time instructional aides, one part-time secretary, and one part-time custodian. Blake school receives administration services and Speech/Language services, which are contracted through Kern County Superintendent of Schools. The school board consists of 3 board members. The instructional day begins at 8:00 am, and ends at 3:00 pm, Monday through Thursday. On Fridays, the day begins at 8:00 am, and ends at 1:00 pm. The school provides after school programs for expanded learning opportunities Monday through Thursdays from 7-8am and 3-4pm. The school district

has a resource room/computer room, which has a total of 2 student computers, 27 Chromebooks and one laptop with a Smartboard, all with T1 internet access. For students who are at high risk, tutoring is available, as well as small group workshops.

All monthly board meetings (except for any Closed Sessions) are open to the public. Any concerned parent that is not a member of the Board is more than welcome to attend and provide comments that are considered in all decision making. Since there is no bus, the teacher/principal and parents have daily contact when the students are dropped off and/or picked up. Some parents are also classroom volunteers. The parents are also consulted during parent/teacher conferences held at the end of the first quarter and every quarter by request. Blake School also utilizes an annual survey of parents, students, and community members to collect the ideas and priorities of those individuals. The Parent Advisory Team consists of 4 parents, who work together with the teacher/principal to plan and implement activities for the school and the students.

2025-26 School Safety Plan

The Blake School Safety Plan was last updated, reviewed and approved by the board on February 21, 2026. The School Safety Plan was completed in the Fall of 2021 and has been fully implemented.
